What information we collect, use, and why

We collect or use the following personal information for **service updates or marketing purposes**:

- Names and contact details

Lawful bases and data protection rights

Under UK data protection law, we must have a “lawful basis” for collecting and using your personal information. There is a list of possible [lawful bases](#) in the UK GDPR. You can find out more about lawful bases on the ICO’s website.

- **Your right of access** - You have the right to ask us for copies of your personal information. You can request other information such as details about where we get personal information from and who we share personal information with. Our lawful bases for the collection and use of your data

Our lawful bases for collecting or using personal information for **service updates or marketing purposes** are:

- Legitimate interests – we're collecting or using your information because it benefits you, our organisation or someone else, without causing an undue risk of harm to anyone. All of your data protection rights may apply, except the right to portability. Our legitimate interests are:
 - We collect personal details so that we can communicate with supporters of our charity, and users (potential and actual) of our facilities.
 - This benefits our organisation because it helps us fulfil our charitable objects which are defined as: "to establish and run a village hall and to promote for the benefit of the inhabitants of Newton on the Moor within the parish of Newton on the Moor and Swarland without distinction of sex, sexual orientation, age, disability, nationality, race or political, religious or other opinions the provision of facilities for recreation or other leisure time occupation of individuals who have need of such facilities by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances or for the public at large in the interests of social welfare and with the object of improving the conditions of life of the said inhabitants".
 - It benefits those who provide us with their contact details by communicating with them about our activities, and plans.
